MEDOC ELIGIBILITY

I was hoping to have clarification on the subject of MEDOC eligibility for this Newsletter, but have not been successful. National Office has often stated that a dual membership is required for a spouse to be eligible for MEDOC coverage. However there is no mention of this requirement in the MEDOC Travel Insurance Policy. According to Johnson Inc a spouse may be covered, without membership, if a NAFR member includes her/him in a Family Plan. I hope to have more information before the September General Meeting.

LONG TERM CARE INSURANCE

Long Term Care Insurance (LTCI) is another insurance that was offered by Johnson Inc. Johnson is no longer selling this LTCI plan, but is administering those plans that were sold and Sun Life is handling claims. Johnson Inc has not sent any updates to policy holders for many years. If members wish to inquire about the status of their policy, with help from Bill Turnbull and National Office, the telephone sequence to reach the Johnson Inc office for LTCI information is:-
